

CONTRACT



Contract between:

Bright Star Primary School / Nursery
And
Parents and/or Guardian of Learner

Take note:

The person that signs as the 1st person responsible for this contract will be held responsible for all terms and conditions according to the Rules and Regulations of Bright Star Primary School / Nursery in this contract.

In case of death or any other written reason of the 1st responsible person, the person responsible for signing as the 2nd responsible person will be held responsible for all terms and conditions to the Rules Regulations of Bright Star Primary School / Nursery in this contract.

By signing this contract between Bright Star Primary School / Nursery school and myself as the responsible person, I acknowledge that the Registration Fee of R/ 500.00 is paid by signing this contract and that the Registration fee is non-refundable.

1. I, the undersigned, understand that I am responsible for the payments of the school fees of R/ 350.00 (Primary learner) / R/ 350.00 (half day Nursery learner) / R/ 800.00 (full day Nursery learner) per month on a monthly basis for the learner registered in this contract.
2. I, the undersigned, understand that the school fees must be paid in advance for the learner registered in Bright Star Primary School / Nursery on a monthly basis before or on the 3rd day of each month for 11 months. Any late payments will include a penalty fee of 10%.

Take note: if you pay via Internet banking, online banking or EFT payment – make sure that your payment reflects on our bank statements before or on the 3rd of each month to avoid the penalty fee. Late payments will automatically be charged with the penalty fee by our system and cannot be reversed. Registration fee and January school fees are separate.

Registration fee must be paid with registration.

1st payment of school fees is due on the 1st day when school starts in January. Thereafter school fees will be payable in advance not later than the 3rd day of each month.

3. I, the undersigned, accepts that if the school fees of the learner is outstanding for more than 1 (one) month, that the learner will receive no further education until the school fees is being paid up to date. Alternatively Bright Star School's Principal has the authority to inform the 1st and 2nd responsible persons for the learner, that the learner will no longer be accepted in Bright Star Primary School / Nursery.
Take note: No report will be given if the school fees are outstanding.
4. I, the undersigned, acknowledge that legal action will be taken against me as the responsible person for this learner for any outstanding school fees.
5. I, the undersigned, understand that I am not allowed to just take the learner out of Bright Star Primary School / Nursery without notification. School fees must be paid up to date and I, the undersigned have to ask for a Transfer letter from Bright Star Primary School / Nursery.
6. I, the undersigned, accept that no arrangements will be accepted by Bright Star School for any outstanding school fees.

Friday clothes / Sport wear

All learners wear Friday clothes or sport wear every Friday at the cost of R10.00. This is compulsory. Even if the learner don't wear Friday clothes / sport wear and come with their school uniform or if the learner is absent, you are still responsible to pay the R10.00 every Friday.

Social media

Bright Star Primary School / Nursery uses sport and event photos of our learners on our social media platforms for marketing and presentation purposes. By signing this contract, you give permission to Bright Star Primary School / Nursery to use any photos of your child in these presentations to post them to social media. Should you not give permission – it is your responsibility to inform the school and your child that he/she is not allowed to have photographs taken.
